

# Research and Planning (Assignment Office) A/Captain Rob Neuneker

A brief list of recent activity in the Assignment Office for September 2019:

Per General Order 19 A-60, the Station 49 vacancy bid occurred on September 4, 2019. Implementation of the vacancy awards will be October 5, 2019.

Labor/Management continues to work to rebalance the current tours for City Suppression. The goal is to more evenly balance daily staffing so that the Department can best respond to critical needs or mutual aid deployments. Additionally, balanced tours will evenly distribute the WDO opportunities and well as mandatory WDO obligations.

The Assignment Office has completed hiring for the twenty candidates of the H3L1 Academy class which began August 26, 2019.

Per General Order 10 A-63, the Annual Seniority list was issued August 30, 2019.

The Assignment Office continues to collaborate with the Information Technology, Human Resources and Payroll Departments with the Q/A functions for eMerge payroll process, a 20% increase in the Assignment Office duties.

## Support Services - ADC Dawn DeWitt

#### Support Services HQ

- A total of 150 facility requests for service were received and processed for the month of August 2019 and 179 service items were closed during the same time frame. We are checking with stations and updating our HRMS.
- Completed the move of new Water Supply Officer, Captain Brent Stuckert.
- Completed cleaning of Chief's Residence. Setting up for Stress Unit transfer into residence.

#### Fire Environmental Health Services (Anthony Boone)

- Update CERS to reflect new responsible point of contact (ADC DeWitt).
- Provided air sampling data and report regarding Ward No-Smoke Filters to ADC DeWitt.
- Began corrections on CUPA (Certified Uniform Program Agency) findings at several fire stations.
- Provided quote for Nilfisk HEPA vacuums.
- Conducted ergonomic evaluations in Assignment Office and Administrative Office of Chief of Department.
- Attended National Safety Congress in San Diego, CA.

#### E.S.E.R. BOND 2010 NFS - AUGUST 2019

#### Seismic Improvement Program:

- Fire Station 16 (\$14.2M) The approved Substantial Completion date was July 16, 2018. Contractor achieved Substantial Completion on January 10, 2019. Public Works has assessed Liquidated Damages from July 17, 2018 to June 5, 2019, in the amount of \$489,500. SFFD moved into the new facility and reactivated the station on January 16, 2019. Conditional Final Completion letter sent to Roebuck on June 5, 2019 is pending installation of aspirator smoke detector. Anticipated completion for this work is end of September 2019.
- Fire Station 5 (\$21.0M) SFFD moved into the new facility and reactivated the station on April 30, 2019. Final Completion is anticipated to be achieved in September 2019 pending final change order negotiations with the contractor.

#### Additional Focused Scope Program:

- Apparatus Bay Doors:
  - o **General:** Public Works has awarded 2 JOC Master Contracts to the following contractors. Work will be issued on a Task Order basis and will be detailed below. Work will be distributed amongst the 2 contractors based on their performance and ability to meet schedule milestones to complete the work.
  - o **JOC No. J45 National Garage Door Company:** Public Works awarded a Master Job Order Contract (JOC) to National Garage Door Company on April 29, 2019. The contract was executed on June 21, 2019.

■ Task Order #1 (FS 8, 28, 29): Public Works issued scope documents to the contractor on July 5, 2019 for review and pricing. The project team conducted site visits of each of the stations on July 31, 2019. Contractor to submit pricing for review and approval. Material procurement is anticipated in September 2019.

#### • Emergency Generators:

Fire Station 14 – Scope of work: replacement of existing generator with new rooftop generator, new subgrade fuel fill port and sump pump at the sidewalk in front of the station, and new fuel piping from sidewalk to generator. Public Works to file for DBI building permit in Fall 2019, with construction anticipated to begin in Summer 2020.

#### E.S.E.R. BOND 2014 NFS - AUGUST 2019

#### Seismic Improvement Program:

- **Fireboat Station 35** Notice to Proceed for Design-Build Services was issued on October 10, 2017. The approved Substantial and Final Completion dates are September 29, 2020 and November 9, 2020, respectively.
  - o Float & Marine Construction (Addendum No. 1)
    - Permit
      - Port issued the approved float permit on July 25, 2019.
    - Fabrication
      - NTP for float fabrication was issued on June 6, 2019.
      - Design-Builder's subcontractor, ZPMC, began fabrication activities in Shanghai, China.
  - o Demolition (Addendum No. 2)
    - Permit
      - Port issued the approved demolition permit on August 19, 2019.
    - Demolition
      - Work is scheduled to begin at Pier 22 ½ on September 30, 2019; includes exploratory survey of the existing conditions and demolition of the existing finger piers & shed (this will require relocation of the fireboats to Pier 26).
  - o Building (Addendum No. 3)
    - Design
      - On April 30, 2019, Design-Builder submitted 90% Construction Documents. The City provided comments on May 14, 2019. The Design-Builder responded to the City's comments on May 22, 2019.
    - Permit
      - On March 6, 2019, Design-Builder submitted permit set to Port for review.
         Issuance is pending accessibility, fire marshal, and planning review and approval.
- Pier 26 Fireboat Berths PG&E has committed to begin their scope of work on September 30, 2019. Once PG&E completes their work, the contractor will finish their contract work to achieve Substantial Completion.

#### Comprehensive Renovation Program:

• Fire Station 7 – Scope of work is primarily new kitchen and apparatus bay doors with selected finishes and other upgrades. Public Works completed 95% Construction Documents on August 22, 2017. DBI issued approved permit on October 18, 2017. This project is ON HOLD while Public Works and SFFD finalize the list of seismic projects for ESER 2020. This project will either proceed as planned or be cancelled.

#### Focused Scope Program:

Work progresses through the 9 scope categories comprising Emergency Generator Replacements, Roofing, Apparatus Bay Door Replacements, Exterior Envelope Improvements, Windows, Showers, HVAC/Mechanical, Sidewalk/Slabs, and Security Access Control.

#### • Emergency Generators:

- o FS 31 Scope of work: replace existing non-operational generator with a new 72 hour run-time generator set. Public Works awarded a \$219,331 contract to BBJ Electric on June 13, 2019. A Pre-Construction Conference was held on July 16, 2019. NTP issued on August 5, 2019. ## Water Supply Officer

- 1. Working with CDD and Mueller Hydrants to come up with a Gleeson Valve alternative. These will be used to outfit the new hose tenders and replace Gleeson Valves that can't be repaired. Gleeson Valves are required to use our High Pressure Hydrants, and the portable hydrants dropped by our hose tenders. They do have a working prototype and should be able to accommodate our specific requirements.
- 2. Monitoring the construction progress at Pump Station #2. The pump station will have to be taken off-line during certain phases of the construction, and we are working on ways to keep this time the shortest possible.

- 3. Working with the Port Fire Marshal and the Port Authority to ensure that the pier required by the fire boat to pump into the Salt Water Intake Manifold located at the Illinois St. Bridge is kept clear of any boat or barge traffic.
- 4. Coordinating a drill with the SFFD and the Water Department. The drill will consist of the Fireboat pumping into a Salt Water Intake Manifold, and SFFD units connecting Gleeson Valves to high pressure hydrants and flowing water. Will also be performing the quarterly SCADA system testing.
- 5. Attending meetings with the developers of the Candlestick Point Project. Language has been approved by all parties that ensures the development will provide the project with the required flow and psi to the AWSS system.
- 6. Followed up on all broken hydrant reports and reported all hydrant maintenance issues to the Water Department. I updated broken hydrant procedures. I am working with IT department to give me the ability to update hydrant information that units in the field are working with. Next project is to update cistern inspection process and provide detailed information about cistern sizes and conditions to the engine companies inspecting them.
- 7. Began conversation with George Cumberland the Senior Engineer of Operations of Rec and Park. I am trying to get permission for the SFFD to utilize the Parks stored water. This water is used to fill the lakes in the park and to pressurize their irrigation system. They currently have 1,000,000 gallons stored and will be constructing storage for 2,000,000 more gallons.
- 8. Began inspection and testing the Fulton St. hydrants that are connected to Stow Lake and Spreckels Lake. These lakes have 20,000,000 gallons of water that can be used by the SFFD. These hydrants are located in the Richmond District that is not served currently by the AWSS pipeline system.
