Lithium Ion Battery Awareness April 2024

BACKGROUND

Lithium Ion Battery technology is increasing in availability and acceptance and so is its infrastructure. The Federal Infrastructure and Investment and Jobs Act of 2021 provided \$6B to battery storage, \$7.5B to rapid charging stations and \$1B to electric school buses. With more and more electric vehicles on the road and the increased regulation for motor vehicles in California, the SFFD will continue to encounter these hazards. Micro mobility devices have increased in affordability and popularity. E-bikes, electric scooters, hoover boards and one-wheels are seen on City streets and can be found charging throughout the city in businesses, single family, and multi-family dwellings.

The San Francisco Fire Department has been responding to lithium ion battery fires with more frequency. This training bulletin is intended to provide awareness training needed for our department members to identify and safely mitigate these incidents.

PURPOSE

- To establish a policy for San Francisco Fire Department's handling of Lithium Ion batteries when encountered
- To establish clear operation guidelines for Lithium Ion Batteries
- Describe the hazards that may be encountered when dealing with Lithium Ion Batteries

DEFINITIONS

Non-Rechargeable Batteries (Lithium Metal): High energy density in a stable medium. Lithium metal strip found inside provides energy; and lithium metal strip is extremely water reactive. Examples are standard AAA, AA, C, D cell and 9 Volt batteries.

Rechargeable Batteries (Lithium Ion): Good memory resistance and stable medium. Cylindrical style batteries are most common for mobile applications. The 18650 and 21700 are named after their metric sizes of 18mm by 65mm and 21mm by 70mm and are found in E-bikes, electric scooters, hoover boards and power tools. Increasing the battery size from 18650 to 21700 yields 50% greater energy capacity and requires 33% less batteries per pack.

Cylindrical cells continue to evolve and increase in size. Increasing the size of the battery leads to both an increase in stored energy and heat dissipation from the core. Electric Vehicles (EVs) are moving to larger 4680 (46mm by 80mm) batteries. Typically, EVs require between 3,000 – 7,000 individual cells to power the vehicle. Prismatic cell and Pouch cell are other types of lithium ion batteries commonly found in cell phones and laptops. Currently, prismatic cell technology is under development for EVs.

Although different in size, shape, and stored energy, all of these batteries behave similarly during an emergency.

Battery Energy Storage Systems (ESS): Most dangerous and have the highest risk for firefighter injury. Large systems found throughout most metropolitan and industrial areas; and it is assumed that large buildings such as hospitals and hotels will transition to these types of systems. ESS should be expected in any new solar installation and will be more frequently found in garage or utility spaces as the technology grows.

NFPA 855: Standard for the installation of Stationary Energy Storage Systems.

Thermal Runaway: Chemical reaction with rapid degradation; does not require oxygen and is nearly impossible to stop once it starts.

<u>LITHIUM ION BATTERY FIRES – GENERAL INFORMATION</u>

- 1. Toxic atmosphere Hydrogen Fluoride (HF), Phosphorus Pentafluoride (PF5) and Phosphoryl Fluoride (POF3)
- 2. Burn hotter
- 3. Lithium can burn without oxygen (cannot smother to suppress)
- 4. Explosive potential hydrogen gas release and build-up
- 5. Thermal Runaway reaction
 - a. Chemical reaction with rapid degradation
 - b. Does not require oxygen
 - c. Nearly impossible to stop once it starts
 - d. Could happen in seconds or days
 - e. Reigniting is common and can occur up to 21 days after.

SAFETY

When Lithium Ion Batteries fail, they release toxic gas within 2-3 seconds. The fire and heat hazards are secondary to the inhalation of toxic gases. Hydrogen gas buildup is an explosion hazard and Lithium-Ion Battery fires burn hotter and may reignite at any time. The policy of the San Francisco Fire Department is to not operate in the immediate area or handle Lithium-Ion Batteries without donning SCBA and structural firefighting personal protective equipment.

ELECTRIC VEHICLES

Lithium-Ion Batteries are located primarily on the underside of electric vehicles. The key to success is early battery involvement identification.

Identify Lithium Ion Batteries are involved

- White smoke
- Battery cell projectiles
- Hissing/popping sounds

ELECTRIC VEHICLE OPERATIONS

If extinguishment is required, secure a water supply. Water is considered the best cooling agent for fire suppression. Water needs to be applied under the vehicle and up at the batteries. Water application directly to the underside of the vehicle battery compartment is recommended. This can be the difference in 10,000 plus gallons of water used or as little as 2,000 gallons with significantly shorter on-scene resource commitment.

If possible, ensure no threat to life or property and allow these fires to burn to completion. Protect exposure from a distance. This tactic will likely yield a faster, self-mitigating event rather than extinguishment. Letting the vehicle burn will release the stranded energy in the batteries rendering the vehicle safe.

Many single vehicle fires have taken hours to control. Several single vehicle fires have resulted in reigniting at the junkyard, hours or days later creating a much bigger incident.

MICRO MOBILITY DEVICES include E-BIKES, SCOOTERS, HOOVER BOARDS, ETC.

- Public exposure concerns due to storage and charging in occupied residences, apartment buildings and businesses
- Often charged near entrance to residence, office or in bedrooms
- Hold significant amount of potential energy and off gas toxic fumes
- Ignite with little to no warning
- Rekindle is likely and removing all batteries as part of overhaul is imperative

Lithium Ion battery failure creates a toxic environment for occupants while fire and smoke are rapidly dispersed. Fire ignition after off-gassing occurs rapidly and often before smoke detectors can alert occupants. The state of charge of these batteries is directly related to the energy discharged during battery conflagration. They do not need to be charging to be a threat for thermal runaway reaction, although often, the charging process can be a catalyst. Once fire is suppressed, remaining batteries can off-gas and discharge their energy at any time during the overhaul phase or after we leave the incident. This poses an additional risk to fire crews, fire investigators or residents after the scene appears to be safe.

MICRO MOBILITY DEVICE OPERATIONS

Department issued hand lines deliver the volume of water required to extinguish a Lithium-Ion Battery fire inside a structure. Water application should continue until conditions are dormant; that is when no more flame, gas or smoke is being released from the battery pack or device.

Lithium-Ion Batteries or Micro Mobility Devices which are involved in fire, found within the fire area, or subjected to elevated temperatures from a fire must be moved from the area in which members will be operating. **This shall occur before overhaul operations begin.**

When a Lithium-Ion Battery fire involves a serious injury, fatality, or potential crime, all members operating should be aware of the need for scene preservation prior to the arrival of the Bureau of Fire Investigation and other Law Enforcement Agencies.

Prior to overhaul, members should conduct a diligent search for battery cells which may have become dislodged from the battery pack.

REMOVING LITHIUM ION BATTERIES FROM BUILDING

Firefighters should move Lithium-Ion Batteries by use of a non-conductive tool (square shovel with wooden handle). The batteries or devices must be moved to the following location in order of preference until the Hazardous Materials Unit has appropriately mitigated the hazard:

- 1. Bathtub in fire unit submerging all batteries in water
- 2. Sink in fire unit capable of submerging all batteries in water
- 3. Garbage bucket or pail capable of submerging all batteries in water

If the above options are not practical, the Incident Commander may remove the batteries or devices via window. If removal via window is not practical, the Incident Commander may move

the batteries and devices to a different location on the fire floor. The batteries and devices must be monitored by an Engine Company and protected by a charged hose line. This must remain in place until mitigated by the Hazardous Materials Unit.

A Lithium-Ion Battery or Micro Mobility Device is not to be moved in an elevator or via stairs unless mitigated by the Hazardous Materials Unit and approved by the Incident Commander.

INCIDENT COMMAND CONSIDERATIONS

- 1. Consult with Battalion 02 or have the Hazardous Materials Unit respond to any incident to further assist in mitigation.
- 2. Charged hose line shall remain in place until Hazardous Materials Unit completes mitigation procedures.
- 3. Establishing a fire watch for the batteries while waiting for their removal from the fire building should be determined by the Incident Commander after consulting with Battalion 02.
- 4. Fire watch may be needed for a prolonged period until the proper removal of Lithium-Ion Batteries can be coordinated by Battalion 02 and the Department of Public Health. Determination and other logistical needs will need to be coordinated by the Incident Commander with guidance from Battalion 02, the Hazardous Materials Unit, and the Department of Public Health.

CONCLUSION

Due to the rapid smoke and flame potential of Lithium Ion batteries, wear your personal protective structural firefighting equipment and SCBA for respiratory protection. Look for signs of battery involvement and compromise. Allow lithium ion battery fires to burn to completion if possible. If extinguishment is required at EV fires, ensure you secure a water supply and apply water directly to the underside of the vehicle battery compartment. Perform thorough overhaul and remove all batteries from structure or other flammable materials. Watch for possible reignition and wear PPE when moving batteries especially in stairwells, hallways, and other tight spaces. Incident Commanders are recommended to consult with Battalion 02, brief them on the incident, mitigation status, or needs to mitigate the hazard.











Fire Alarm Sleeping Area Upgrade Project




Overall Annual R1/R2 Inspections (2024/2025)







Permit Annual Inspections by Section (Permits Section)





Permit Annual Inspections by Section (High-Rise)





Permit Annual Inspections by Section (Districts Section)





- 8/16: Attended the Golden Gate Bridge drills with multiple agencies to train on net rescues
- 8/19: Met with Dept. of Technology to discuss our uses and limitations with our drone that was recently purchased to film training evolutions.
- 8/20: Attended the funeral for Father Edward Reese
- 8/25, 8/26, and 8/27: Attended the Art of Reading Smoke" class at the Main Library.
- 8/26 and 8/27: Assisted command staff in picking candidates for the Chief's Interview process for the upcoming 137th Academy.
- 8/29: Attended the filming of the first inaugural podcast for SFFD with CD1, retired CD2 Wyrsch, and retired Lt Salas.
- 8/11 8/15: The DOT hosted Rope Rescue Awareness and Operations class for 12 of our members

Activities and Projects:

- I am continuing to support B4 to complete open task-book for Station 16 members for Large Vessel Boat Operations. We have been fully operational daily with the completion of task books and engagement from the personnel at Station 16.
- The 136th academy is doing very well. They have completed 2 rounds of testing and are progressing nicely.
- Special Ops continued the drills at the Golden Gate Bridge using the nets on the bridge. This is to simulate rescuing the victims from the net using rope systems and is coordinated with several agencies

- The DOT hosted a "Reading Smoke" class at the SF Main Library on 8/25, 8/26, and 8/28. The class was filmed by SFGov TV and will be placed on Vector Solutions so it can be viewed by all our members. The class was attended by approx. 200 members over 3 days.
- I am currently in contact with WAYMO to put together a Full Box response at a vacant location on Treasure Island. A WAYMO engineer and representative will be present and will program the WAYMO system to react to the situation to help with future scenarios throughout the city.
- The DOT hosted a "Dry Decon" class for HazMat response on 8/11. This class was free to our members and was paid for using CJAC funds.
- The DOT staffed an open H16 position which will provide video training to utilize our Vector Solutions application and develop our training website. This position will create CJAC revenue through the video training from our apprentice members (<5 years).
- The DOT is moving forward with developing a Rope Rescue Awareness and Operations Cadre. We hosted a class on 8/11 with CJAC funds. This class will also task book our internal instructors so we can continue this class internally free to our members. This class is the gateway to several other certifications that staff our specialty units. We hope to have a large cadre very soon and hope to give this course as an academy curriculum in future classes
- In-Service staff are currently taking training to the field and visiting stations to conduct training. This will continue to happen between large modules and will utilize fire houses and other locations in the city.
- EMS Training has wrapped up recruit training and preparing for the next group. They are continuing to address licensure and continuing education.
- The DOT is hosting a Public Safety Diver class in October which is free to our members and funded by CJAC.
- The DOT is hosting Fire Inspector 1A-1D in October, November, and December which is funded through CJAC. It is free to our members and will be taught by Lt. Jason Woo from BFP.
- The DOT is coordinating a large scale rescue operations drill with Task Force 5 called MOBEX. This task force is from So. California. We anticipate it to be in early January between academy classes at TITF. This will be an educational experience for our officers and chiefs in which we can be involved. This will also prepare us for the development of a future Rescue Task Force with SFFD. Task Force 5 representatives were very complimentary and excited about the use of our Treasure Island Training Facility.
- The DOT is working with BC Jim O'Connell on an upcoming Truck Academy which will be free to our members. We anticipate this to take place in September.
- The DOT will be hosting state fire marshal fire investigation 1A and 1B in February. This will be paid using CJAC funds and will prepare our members for fire investigation and also for the tentative H6 exam in spring 2026.
- I am currently working with Chief of Staff Sims to put on Media Training for our command staff, PIO's and union board. It will be funded by CJAC at no cost to our members.
- Completion of registration with the federal excess program is almost complete. It is being
 wrapped up by the Board of Supervisors and the city attorney. This program will allow us to
 obtain training materials, industrial vehicles such as forklifts, and other resources free of charge.
 We were enrolled in this program prior but needed to re-enroll due to the many changes in city
 government and command staff.
- In Service Training has completed the fabrication of a steel forcible entry gate prop for the 2nd floor landing of the Folsom Training tower. This will simulate a tunnel entrance gate to further


- enhance learning opportunities at our Folsom location. It will have the obstruction of the interior stairwell wall to navigate.
- In Service staff are fabricating simulated power lines for the Folsom tower that can be moved and adjusted as needed.
- The CCSF intern program has started, and we have several volunteers at several stations throughout the city. There are also interns at DOT to learn as well. The interns at DOT do not have their EMT certifications yet so they cannot work in the field.
- I am working with the Training Committee on a Training Bulletin
- to update our suggested pump pressure as the efficiency of pumps and hoses has increased since our standard were written. Several tests with flow meters have been conducted to obtain this information.



August 2025 Monthly Report

In August, we concentrated the majority of our efforts in the discipline of rope rescue. We have been preparing for the next level events and are actually delivering on that promise. We also have been spending time developing and planning for bigger more collaborative events later in September and October.

The first week of August, FF/PM Canning and I conducted interviews for open Helicopter Rescue Technician (HRT) team. There was a total of 15 interviews for 2 spots. It was a chance for me to meet dedicated individuals from the H3 rank who aspire to be professional rescue technicians. I believe the program is gaining acceptance as a very good option for those hard to access rescue scenarios where time is critical. I was also impressed with the specialized training that it takes just to become eligible to be a HRT. The HRT program continues to move in a positive direction and it is my hope to expand the training to more members as we grow.

One of our goals for the DOT is to be able to teach Rope Rescue Awareness & Operations training "inhouse" to all our members. We are getting closer to that goal. In week 2 of August, FF/PM Canning and I began our task books and instructed 12 of our SFFD members in the basics of rope rescue on Treasure Island. In terms of RRAO equipment, our order to make our inventory complete was approved and CJAC funds to cover the costs. There is another scheduled RRAO class in November where both of us are expected to complete our training. We plan to conduct quarterly RRAO classes within the SFFD beginning January 2026.

Special Operations continues to make contacts and collaborating with outside agencies. FF Jason Harrell (retired) has been instrumental for fostering and re-vitalizing collaborative relationships with Bay Area agencies. We continue to meet and train collaboratively with the California Highway Patrol, Golden Gate Bridge Authority, and Southern Marin Fire.

Our 2 biggest rope training days happened on 8/17 and 8/30 with successful results. On both these days, Engine 14, Truck 14, Rescue 1 & 2, with BC7 and BC2 were able to conduct suicide net rescue training on the actual Northern span of the Golden Gate Bridge. SFFD crews worked alongside GGB Iron workers and Southern Marin Fire Rescue to rescue victims (training dummies) in the suicide nets. This is the first time in recent memory (10 plus years plus) of being able to train on the bridge and the first time since the suicide nets were erected. This session was invaluable for development of our SOPs in the future.

During the last week of August, eight SFFD members were enrolled in the Rope Rescue Technician class instructed by NCRT. This class was hosted by SFFD and funded through BATEP-UASI thus free for those who were able to register. There were 105 sign ups for only 24 spots. Many hopeful SFFD members were turned away. What this tells me is that there is a great demand for higher level and next level training by our members. We should be working to be in a position to teach classes, host classes, and even help off-set the costs of training.

For the month of September, we will continue to incorporate the new CMC Clutch, Capto, and Petzl ID into more advanced rope rescue scenarios. I plan to expand CMC Clutch and Capto ground school

training to Station 14 and 19 due to their rope operations response areas. We will continue to collaborate rope training with GGBA and SMF for our last scheduled Suicide Net Operations on the Golden Gate Bridge on 9/7. If all goes according to plan, we will continue to train and collaborate by meeting in the middle of the GG Bridge where we will be over the water and unprotected from high winds. There has been requests to assist with stokes basket rescue and victim packaging from an aerial ladder by BC Kircher and BC Hoo for Truck 11, Truck 15, and Truck 19. This is in preparation for the BART rescue drill from elevated tracks scheduled for the first weekend of October. We will continue to be a resource for companies and chiefs in the field and help with all training when there is a need.




