



## October 2025 BHU Calls for Service Highlights:

- Calls for service continue to increase, illustrating a growing awareness of the BHU team, greater comfort with accessing BHU services (reduced mental health stigma), and a growing demand for first responder support services.
  - Calls for service in October 2025: 360 compared to October 2024: 145. This is a 248%increase in calls for support and behavioral health resources provided compared to October 2024.
- October 2025 Top Reported Stressors:
  - o Critical Incident Response: pediatric traumas, motor vehicle accidents, suicide, and homicide were the most frequent type of critical call response.
  - o Career Concerns: leave due to workplace injuries, interpersonal concerns at station, moral injury.
  - o General Stress: referrals to EAP therapy, family therapy, and anger management.
  - Alcohol and Substance Use: members and family members seeking treatment/recovery support.
  - o Family/Marital Problems: therapy for children, couples counseling, separation/divorce, child custody.



## **Random Alcohol and Drug Testing Program**

- The Random Alcohol and Drug Testing Program was compliant for the month of October. No positive tests were recorded. Monthly checks of testing equipment / inventory completed for ISB 1&2, AP, D2, D3, and MD office.
- ISB equipment & supplies at sufficient levels.
- Continued to monitor last chance agreements and testing as outlined in agreements.
- The Fireboat / Engineer testing is under the ISB random testing program, and the names are added to the draw pool daily from Datco Services.

#### Conditional Offer, Promotional and End-of-Probation Alcohol and Drug Testing Program

- Ten (10) members participated in pre-employment, promotional, and end of probation alcohol and drug testing with the M.D. office. Six (6) DOJ LiveScan were also completed (for the EMS recertification division).

#### **Post Accident Investigations**

- Zero (0) post-accident investigations were conducted by ISB in October.

#### California Driver Licenses (CDL)

- Cpt Carter continued to monitor all dept. members' driver licenses via CA DMV Pull Notifications.
- ISB continued driver license audits. Added new employees into DMV system and removed employees no longer employed by SFFD.
- ISB office continued to update all members' licenses and DL546 health questionnaire forms in HRMS. Forty-four (44) CDLs updated/renewed in October. CD3 memo (25-03) was released 5/21/25 to assist getting all members current with DMV health questionnaires and completing the Firefighter endorsement on their driver licenses. One-Hundred-Thirty-Nine (139) DL546 forms completed and verified with the DMV between 10/01/25 and 10/31/25.

#### **Background Investigations**

- ISB began preparing for the next H2 academy (137<sup>th</sup>) background process. DMV records and Investigative reports were acquired by ISB on these candidates. Fifty-Four H2 candidates sent to

ISB for in-depth background investigations. Intake interviews for these candidates will begin 11/3/2025.

- ISB continued digitizing records of completed background classes to adequately store personnel records. Many thanks to FF Youngblood for her assistance in a modified duty position. FF Youngblood finished her modified duty assignment at ISB on 10/29/2025.

• 27 service calls were placed to resolve minor plumbing issues (faucet, toilet, urinal repairs; clogged sinks, shower drains) in the month of October. Three sewage backups were reported and resolved during this month (FS 9, 40, 42). DPW plumbers performed preventative service jetting of sewer lines prior to rainy season (FS 5, 5, 7, 8, 10, 12, 20, 21, 23, 33, 38, 43) at Stations with a known history of drain backups in heavy rain.

#### HVAC/HEATING/BOILER

**FS 15: Boiler replacement approved due to boiler failure**. Work has begun and is expected to be complete in mid-November. Portable heaters delivered to Station in the interim.

**FS 17:** Boiler replacement estimate is being revised by DPW Steamfitters for consideration. Status Update: Estimate was submitted to SFFD in March. SO# 2484755. ESER funds have been approved, and job is in planning stage. **Labor availability expected upon completion of FS 15 boiler.** 

FS 23: Heater in Officer's Room needs to be replaced including new t-stats, on-off switch. Drying Room needs new heater and exhaust fan. Modifying controls to include timer and on/off switch in or outside the Drying Room. Waiting for a quote from DPW's Steamfitters Shop for two heaters, one exhaust fan and the necessary control work. Quote received from DPW, in for ADC of Support Service's review. ADC of Support Services requested that a quote be provided just for the fan coil replacement. Steamfitters propose to modify the existing estimate and resend mid-July. SO # 2115449 was submitted to SFFD for the Officers Room heater replacement. Waiting on Client approval. Approved by SFFD. A unit heater has been ordered. Status Update: Waiting for unit to arrive. Heater was completed 9/19

FS 29: SO #2249790 Heating system is down. Noted that the pumps here on this system are frequently replaced. Steamfitters are recommending re-pipe unit similar to FS 12. Waiting on Client approval. SFFD approved scope of work to be performed. The material estimate has been submitted to DPW's Purchasing Department. Status Update: Waiting for SFFD approval to order additional materials as needed. Work has been approved, awaiting labor availability. Work completed 9/10.

**FS 37**: RADIATORS It was discovered that 17 radiators need new valves to control on/off. Nine units do not work. Waiting for the proposal to change out all valves. The Drying Room Heater needs a 3-way valve and an outdoor air override that needs to be installed. Proposing two men to take nine days, plus \$3500 in parts. The heat is on in the

Station and the new program settings are adequate to get through the winter. Work will need to be done when they are permitted to shut boiler down for a few days. Waiting for a formal quote to be sent to ADC Support Services to sign off. Deferred by SFFD, however DPW will be submitting a new estimate for the boiler work. Status Updates: Estimates for the controls work and radiator valves submitted to SFFD for approval. Work approved, awaiting materials.

#### **ROOFING**

FS 9: Roof replacement NTP 8/11/25. Work is in progress. 90% complete.

#### CEMENT/ASPHALT

No major cement/asphalt issues were reported.

#### **EXHAUST EXTRACTORS**

For October, there were two stations that reported issues with their equipment. FS15 issue from September has been repaired. FS 13, 42 issues reported in last two days of October. Work has been assigned.

## Focused Scope Program (Michael Rossetto, San Francisco Public Works):

Total Funding allocated for the Focused Scope Program is \$21,407,279, approved by SFFD on 8/17/17. Work is complete in 8 of 9 of the Focused Scope categories comprising Roofing, Apparatus Bay Door Replacements, Exterior Envelope Improvements, Windows, Showers, HVAC/Mechanical, Sidewalk/Slabs, and Security Access Control. Work continues to progress through the last scope category, Generator Replacements.

#### **Emergency Generators:**

- FS 2 Scope of work: replace existing rooftop generator set, structurally strengthen roof structure to support new fuel tank with capacity for 72-hour run time and provide new fuel fill port and piping to generator.
   This project is complete.
- o FS 19 Scope of work: replace existing generator at grade and replace main electrical panel.
  - The generator load bank lead time has increased, causing a generator delivery date into 2026. The Load bank lead time pushed the anticipated generator ship date to from November 2025 to May 2026, but recent input from the contractor indicates improvement in lead time. The PG&E service agreement is set to expire in February 2026, which will not work with the project schedule due to the generator lead time. The PM submitted a new service agreement application to SFPUC/PG&E. The new service agreement is expected to take approximately 6-8 months to be issued by PG&E, pushing PG&E's involvement to March-May 2026, needed near the onset of on-site construction activities.
- o FS 14 Scope of work: Redesign of the previous replacement of the existing generator with new rooftop generator, new subgrade fuel fill port at the sidewalk in front of the station, and new fuel piping from sidewalk to generator is underway.

• SFFD Fire Prevention has approved BOA's AB-005 request to deliver the fuel via hose or hand-carried containers to the rear yard. The project will be submitted to DBI for permit pending receipt of a Planning approval letter acknowledging no action due to the redesign.

#### **Exterior Envelope:**

- o **Package 1 (FS 8, 20, 23, 29)** FS 8, 20, and 29 are complete; On 1/15/21, SFFD requested a hold on FS 23 painting due to other priorities.
- o **Package 2 (FS 24, 34)** This project remains on HOLD initially placed at the request of Capital Planning to provide supplemental funding to the Police TC&FSD project. It is now expected that those funds will be returned to the SFFD for allocation to a priority project, possibly FS24 and/or FS34.
- o **FS 2, 17, 24 & 31** Water Intrusion Assessment (Lisa Zhuo, San Francisco Public Works) This project kicked-off on 10/6/2025. The waterproofing consultant McGinnis Chen Associates will begin investigative work at Fire Station 24 on 10/28/2025.

#### **Miscellaneous:**

FS35 Security Fence Enhancements, FS17 Boiler Replacement & FS 29 Apparatus Bay Door Replacement were requested as new projects by SFFD in August 2023. These are ranked as the highest priority (most urgent) projects after the Network Modernization project.

- o FS 17 − Boiler Replacement. Requested to reinitiate previously on hold, per SFFD 5/5/25 email. A revised budget was approved by SFFD and DPW-BBSR has issued purchase orders to vendors for materials and equipment procurement. The boiler has been received. Pumps and other materials on the way. Demolition is anticipated to begin in November 2025.
- o FS 29 Apparatus Bay Door Replacement: completed and is in close-out
- o DOT/FS 7 Railings: completed and in close-out
- o **FS 19 Window Replacement** budget was requested by SFFD, per email from 5/5/25. The Planning Department has agreed to allow replacement of the existing wood windows frames with aluminum on the condition that the aluminum profiles are like the existing wood profiles. This will be reviewed as part of the building permit application. An on-site scoping meeting was held in August between BOA, BPM & the BBSR glaziers. A subsequent window and hazardous materials investigation was carried out on 10/15/25. Asbestos was found in caulking samples. The DPW Glazier has reported that some windows are in good shape and do not require replacement. The Glazier will return to assess window hardware and other recommended repairs for the windows that may remain.

#### **Network Modernization Project (Michael Rossetto, San Francisco Public Works):**

As of June 2025, all fire stations have been completed and inspected, excluding station 51 which is under the Jurisdiction of The Presidio Trust who is requiring agreement modification with SFFD to allow the work to proceed. SFFD has been communicating with CAT for the

Agreement modification. 9/18/25 SFFD advised DPW that the Presidio Trust will consider the building permit, submitted by DPW in January 2025. The DPW PM is in contact with the Trust and is processing the permit fee payment to the Trust.

- On October 16, 2025, the Planning Commission voted unanimously to recommend approval of the Planning Code Map Amendments (zoning and bulk/height changes). The

full legislation (Street Vacations & Planning Code Map Amendments) is scheduled for the 11/17/25 meeting of the Land Use and Transportation Committee of the Board of Supervisors. Final referral to the full Board of Supervisors for approval anticipated in early December 2025.

# **Operations**

The unit remains fully operational, handling major events and emergency calls. The PIO Unit had an international story about a cliff rescue of a dog that resulted in multiple media interviews.

The unit covered the following events with written, radio, social media, and media coverage: Fleet week, PUC 1989 Drill, NERT Citywide drill, Keep the City Safe, Italian Heritage parade, and many more. We encourage you to view our social accounts for an overview of our work.

The office continues engaging with external agencies and the public, such as attending community meetings, which help keep our office informed about events, perceptions, and issues.

Relief PIOs have been signing up for shifts and rotating through the unit for experience and task book sign-offs.

The office has started preparing for Super Bowl 2025 and all the events that come with it.

In preparation for possible civil unrest, First Amendment activities, and major planned events, the city has activated the Joint Information Center at Level 4, with the option to downgrade to Level 3 as needed. This has caused the office to shift its focus to support JIC roles in addition to its regular duties. We can adapt thanks to a revised roster and ongoing collaborative training with our city partners.

The unit is working on a monthly checklist and charging list for all our digital equipment to make sure it's prepared for our community and department if needed.

In collaboration with MMS, the office has downloaded thousands of digital items to the main MMS computer for archiving and easy access. Much more work is needed for categorizing and coding, but it is a positive step forward.

The PIO teams' channel is running great and has been helping all members of the Department and allied agencies. A WDO tracker has been added to help balance overtime between relief and full-time members.

# **Training and Education**

Members of the PIO team continue to pursue training opportunities to advance our ability to serve our community.

All members receive regular webinars, articles, or digital content related to our job. This helps with ongoing education and improves situational awareness of current events and PIO tactics. Officer in charge Baxter held several virtual meetings with PIO leads from around the nation to improve our knowledge and skills, ensuring we provide the right information to the right people at the right time. This information is shared with members during shift change and has helped us complete the strategic plan, especially the SFO PIO plan.
