3. APPROVAL OF THE MINUTES [Discussion and possible action]

Discussion and possible action to approve meeting minutes.

Commissioner Covington Moved to approve the May 10, 2017 regular meeting Minutes. Commissioner Hardeman Seconded. Motion to approve above Minutes was unanimous.

There was no public comment.

4. CERTIFICATE AND ACKNOWLEDGEMENT OF APPRECIATION OF EMS DISPATCHER RYAN WON

Mr. Rob Smuts of Department of Emergency Management to recognize the outstanding work performed by Dispatcher Ryan Won.

Mr. Bob Smuts was welcomed by President Cleaveland. Mr. Smuts, the Deputy Director for the Department of Emergency Management and who oversees the Division of Emergency Communications presented a certificate to Ryan Won, who was the recipient of the EMS award for this year. He stated that Ryan has been with the DEM for 7 years and has answered thousands of calls and dispatched countless incidents, for both police, fire and medical. He went on to describe a call Ryan took in which a pregnant woman about to give birth. He acknowledged the wonderful job Mr. Won did handling that incident. Chief Hayes-White also acknowledged the great work done by Ryan and stated that two members of the Fire Department, Irene Ybarra and Daniel Nazaretto will also be receiving awards at tomorrow's awards ceremony, along with Mr. Won. Mr. Won thanked the Commission and Chief Hayes-White for the certificate. The Commissioners thanked him for doing a great job and questions and answers followed, along with a photo opportunity.

5. OVERVIEW OF THE 9-1-1 DISPATCH CENTER

Mr. Rob Smuts of the Department of Emergency Management to provide an overview of the operations of the 9-1-1- Dispatch Center.

Mr. Smuts gave a high-level overview of the 9-1-1 Dispatch Center. He explained in detail the attached slide show: http://sf-fire.org/sites/default/files/COMMISSION/Fire%20Commission%20Support%20Documents%202015/EMS%20Presentation.pdf

Mr. Smuts stated that call volume has increased significantly in the last few years, increasing 36 percent in the last five or six years and going from about 2500 calls per day up to about 3600 per day. He stated that slightly more than half are 9-1-1- calls, and the reset are non-emergency calls, most of them police non-emergency n nature. He added that the increase in call volume is one of two main factors that have impacted their service level in recent years, the second factor is a spike in personnel separations and retirements. He touched on the overall operations of a day in the life of a 9-1-1 dispatcher, the difference between a code 2 and code 3 call, the definition of basic life support and advanced life support, the number of technical changes that are still coming down the pike that should have a noticeable improvement in the time it takes for a unit to arrive on scene and the call answering goals in accordance with NFPA standards.

Commissioner Covington thanked Mr. Smuts for his presentation and stated that people think that when they call 9-1-1 with a fire-related emergency, that they are getting the Fire Department when actually they're getting the Department of Emergency Management at the 9-1-1 Center. She asked Mr. Smuts how they factor in people who say they call 91-1- and they never get a response. Mr. Smuts answered that if you call 9-1-1- and don't hang up, you will get a response, they have people that do hang up before the call gets answered. Should that happen, they track the number of abandoned calls and they call back everybody who hangs up. He added that many of those hang ups are accidental dials. He stated that when they are reaching their standards, it takes on average about four seconds to answer the call and in their worst month, it took about 11 seconds, but the call will be answered if you stay on the line even if every second feels like an eternity when you're looking for help. Commissioner Covington asked what they are doing to prevent bun out when they are so understaffed and have mandatory overtime. Mr. Smuts answered that it is one of the biggest challengers they have

and he is working with the Union on changing some aspects of scheduling, introducing a treadmill station and looking at every aspect that they can to relieve the stress of the job while still having people work quite a lot of hours. Commissioner Covington asked if there was a cluster of reasons as to why so many people wash out before finishing training. Mr. Smuts stated that some are dismissed for conduct or who did not successfully complete the phone or radio training portion and there are people who decide that the job really is much more intense than they had anticipated. Commissioner Covington suggested that they should provide as much information to interested pre-hires as possible, including the known challenges, the stress involved, mandatory overtime and things of that nature. Commissioner Covington confirmed with Mr. Smuts that there are national standards for 9-1-1 dispatchers, that they use simulated situations in training and that they hire people who have worked in other dispatch centers.

Commissioner Veronese asked for clarification on the service standard that Mr. Smuts mentioned. It was confirmed that the standard is to answer a call 90 percent within 10 seconds. Mr. Smuts explained the steps of when a call comes in that requires a response from the Fire Department. Commissioner Veronese asked what technology exists when a cell phone call comes in. Mr. Smuts explained that phones have three ways of determining a location, triangulation of cell phone towers, triangulation of Wi-Fi and a GPS devise, but the 9-1-1 system only uses the first because they need to stay within FCC regulations. He added that they have written letters and testified at hearings to encourage the FCC to force the carriers to provide better information. Commissioner Veronese suggested that folks watching the meeting from home or work should get the word out about using the non-emergency number which is (415) 553-0123 which could reduce the 9-1-1 call volume almost in half. He thanked Mr. Smuts and mentioned that he was a huge fan of Ms. Kronenberg and he thinks they are doing a great job with the resources that they have and if there's anything the Commission can do to support them, he should let the Commission know.

Commissioner Hardeman stated he would like to take a tour of the 9-1-1 facility. He complimented Mr. Smuts on the improvements he's making. He asked how the wages and benefit packages for dispatchers compares to other departments. Mr. Smuts stated that they make less than Santa Clara but more than the rest of the Bay Area and that the structure that San Francisco has, where they are unified fire, police and medical as well as geographically unified, his dispatchers are doing more work than a typical dispatcher or a dispatcher really in any other agency that he can point to in the Bay Area. They also support more first responders in the field per dispatcher than other agencies. Commissioner Hardeman commented that he was glad Mr. Smuts acknowledged his appreciation and support of his work force.

Vice President Nakajo acknowledged all the hard work and support of Mr. Smuts and Director Kronenberg during the recent scrutiny and pressure they have been faced with. He mentioned the recent articles that have been in the news. He touched briefly on the history of the dispatch center which once had uniformed dispatchers and now has civilian dispatchers. He proceeded to go page by page of the above presentation for clarification and discussed the hiring plan to staff the office with dispatchers. Mr. Smuts stated that they have found full support by the Mayor's office and Board of Supervisors to get funding to staff their office. Vice President Nakajo suggested that they should explore hiring per-diem employees. Vice President Nakajo encouraged the commissioners to visit the 9-1-1 Center and thanked Mr. Smuts for his presentation.

President Cleaveland thanked Mr. Smuts for his very exhaustive report and mentioned that everyone has learned a lot about the 9-1-1 system. He asked Mr. Smuts if he could add one thing to his department, what that would be. Mr. Smuts answered, besides more trained staff, he would like to expand the building. They spoke about the creation of the ambulance working group and the Marvelous System that allows them to have calculated response times for any incident, and it also shows the six closest ambulances and helps with ambulance deployment positions.

There was no public comment.

6. OVERVIEW OF THE DEPARTMENT'S INVOLVEMENT IN THE TRANSPORTATION ADVISORY STAFF COMMITTEE (TASC)

Assistant Deputy Chief Dan DeCossio to provide an overview of TASC.

Chief DeCossio explained that TASC is all about response times with regard to the Fire Department as well as access to the fire scene or medical emergency. He stated that the Department's role on the committee is a three-pronged approach, which includes the Bureau of Fire Prevention who enforce the regulations for Fire Department access that lives in the fire code in Section 503, Support Services which addresses operational needs of the fleet, turning radius of the rigs, slopes of the streets, etc., and Field Suppression input for fire ground tactics. He stated that the Transportation Advisory Staff Committee is headed by MTA and members consist of Fire, Planning, Police and Public Works Departments. Each department provides input, reviews proposals before the committee and those proposals are basically associated with any kind of street design changes in San Francisco. The input is considered and the committee provides a recommendation to the MTA Board of Directors on how to proceed with each proposal. He added that there are basically three outcomes from the decision; 1) object the proposal; 2) ask that it be placed on hold for further information; and 3) try to resolve the matter in other means. He explained different types of items they are presented at TASC, including bicycle paths and lanes, traffic calming devises such has speed humps and cushions and bulb outs. He touched on challenges that the department has faced, including chicanes, medians, lane reduction removal, traffic circles and paint and safety zones. He described scenarios of the challenges that have impacted the department because of the traffic calming devices as well as the ongoing challenge communicating with other department on what the Fire Department's needs are. He stated that they are working with the City Attorney to give written carination on fire code versus transportation code and which one supersedes the other.

Commissioner Covington thanked Fire Marshal DeCossio for his presentation and stated that she had attended a number of internal TASC meetings. She asked for more information on the simulations that are conducted where it's determined what works and doesn't work for the Department. Chief DeCossio explained that the interested and potentially affected department bureaus go out to the intersection, street or bulb out that is scheduled to be installed and constructed and they perform "cone tests" with the appropriate measurements. They test the equipment and rigs to make sure they can function properly, such as being able to raise the aerial ladders safely and make safe turns without going into oncoming traffic. A general rule of thumb from the Fire Department's perspective is don't make a more hazardous condition. He stated that MTA is working with the department in developing turn templates that accurately reflect the department's fleet which has been helpful in the testing process. Commissioner Covington concluded by stating she requested this item be put on the agenda so that they can get a better picture of how to move forward to obviate some of the difficulties and impasses in the future.

Commissioner Veronese asked if Chief DeCossio will keep the Commission informed on the response from the City Attorney's Office. Chief Hayes-White stated she would keep them apprised.

Commissioner Hardeman thanked Chief DeCossio for his presentation and stated he was delighted he brought up the fact that buildings are going to be built taller in the near future and they need to think of the problems that will arise when they can't access water to suppress a fire or can't rescue somebody out of a building with a ladder truck and he would never vote to allow things to happen that obstruct the ability of the Fire Department to do its job.

6. CHIEF OF DEPARTMENT'S REPORT [Discussion]

REPORT FROM CHIEF OF DEPARTMENT

Report on current issues, activities and events within the Department since the Fire Commission meeting of April 12, 2017, 2017, including budget, academies, special events, communications and outreach to other government agencies and the public.

Chief Hayes-White's report covered events since the last meeting on May 10, 2017. She reported that the budget for this fiscal year remains on track for both revenues and expenditures and they go before the Budget and Finance Committee on June 16th and June 22nd and they will continue to advocate to maintain the current funding and will continue conversations with the Mayor's budget office in terms of enhancements if possible. She added that on May 12, 2017 the Budget Committee was reconvened and she appreciated President Cleaveland and Commissioner Alioto Veronese for attending and stated it was poorly attended even though they reached out to all members. In regards to academies, Chief Hayes-White stated the 122nd academy is in its fifth week and the 123rd academy is anticipated to start in late September. She touched on the good work of the Division of Training and the field chiefs who put on a battalion chiefs academy.

Chief Hayes-White stated that she met with Local 798 for their monthly labor management meeting, she attended a PG& E substation tour, and EMS function at John O'Connell High School to celebrate EMS week, and she met the new Chief of the Emergency Department at SF General, Dr. Chris Colwell. She asked President Cleaveland to consider adjourning the meeting in honor of three retired members of the department, Assistant Chief William Shaughnessy, Assistant Chief Dennis Callahan and Lieutenant Leroy Character.

Commissioner Hardeman thanked the chief for her report and announced that Joe Montana's father passed away yesterday.

There was no public comment.

REPORT FROM ADMINISTRATION, DEPUTY CHIEF RAEMONA WILLIAMS
Report on the Administrative Divisions, Fleet and Facility status, including any updates on Station 49
and the search for a new training facility, Finance, Support Services, Homeland Security and Training
within the Department.

Chief Williams' report covered the period from April 27th to May 24, 2017. She mentioned that the Assignment Office staff is currently working on modifying the Station 49 schedule in anticipation of the upcoming EMS academies and staff has completed back filling the vacancies left by members who were admitted into the 122nd recruit academy. Under homeland Security, she mentioned that Chief Francisco participated in various meetings and training exercises and he continues to update the command staff on all suspicious and potential terrorist activities, including the recent Manchester bombings. He has also been planning the Bay to Breakers event, the Escape from Alcatraz swim, and Fleet Week. She touched on the Investigative Services Bureau, the Physician's Office, and Support Services, which included updates on Pump Station 1, Station 5, Station 16, ESER projects, and Station 49. Under Fleet Management, she reported that they have eight engines that are currently in production with 4 being delivered in August of this year and four more following shortly thereafter. She mentioned that the aerial ladder truck specifications are complete and out to bid with the

proposal due in June and they have all trucks outfitted with cordless extrication tools. With regards to NERT, she stated that Captain Arteseros continues to oversee the emergency preparedness training for the community throughout the city. She touched on the Fire Reserves.

Vice President Nakajo made a brief statement that when he mentioned at the last meeting the retirement dinner he attended, he forgot to mention that it was organized by Firefighter/Paramedic James Green. He also acknowledged that members of the audience, the Chief's staff, several Fire Reserve cadets from City College of San Francisco, and members of department, participated in the Special Olympics that were held at Lowell High School on May 16, 2017.

Member pled guilty to the charges of violating San Francisco Fire Department Rules and Regulations Section 2004- Restricted Passengers; Section 3905 – Familiarity with the Rules; Section 3907 – Safety Rules; Section 3921 – Inattention to Duty; Section 3923 – Acts Detrimental to Welfare of Department; and Section 3941 – Use of Vehicles. Section 4003 – Duty to Report Breach of Duty or Misconduct.

Based on Member's plea, the Commission found Member guilty of violating the rules mentioned above by a vote of 5 to 0 (Ayes: Cleaveland, Nakajo, Covington, Hardeman, Veronese).

Member pled not guilty to the charge of violating Section 3909 – False Reports. The Commission found Member not guilty of violating Section 3909 by a vote of 4 to 1 (Ayes: Cleaveland, Covington, Hardeman, Veronese; Nos: Nakajo).

Regarding the penalty, the Commission voted unanimously (Ayes: Cleaveland, Nakajo, Covington; Hardeman, Veronese) to terminate Member's employment with the Department, but to hold that termination in abeyance for a period of 3 years from the date of the Commission's decision. Should any new charges by lodged against Member during the abeyance period, and should the Commission sustain such new charges, the Commission may (1) terminate Member's employment, or (2) impose the level of discipline the Commission deems appropriate for the new charges.

The Commission further imposed a suspension of 2 calendar months by a vote of 3 to 2 (Ayes: Cleaveland, Hardeman, Veronese; Nos: Nakajo, Covington).

- 1. In order to maximize service to citizens and visitors, SFFD has created separate response vehicles for cliff and surf rescues.
- 2. Effective Tuesday, May 23, 2017, Cliff Rescue units will be placed in service at Station 14 and Station 19. These units will be dedicated as "Cliff Rescue 14" and "Cliff Rescue 19." Primary responsibility for the units will be assigned to the TRUCK Company, however, respective Engine Companies will be expected to be proficient in the response, use, and maintenance of vehicles as well.
- 3. Battalion Chiefs shall ensure proper training is conducted monthly, and is coordinated between both Cliff Rescue units and Rescue Squads. Equipment carried on Cliff Rescue vehicles will be determined by the Technical Rescue Committee, with approval from the Technical Rescue Committee Chair, in consultation with the Bureau of Equipment (BOE).
- 4. Effective Tuesday, May 23, 2017, Surf Rescue units will be placed in service at Station 18 and Station 34. These units will be designated as "Surf Rescue 18" and "Surf Rescue 34." Primary responsibility for the Surf Rescue units will be with the Engine Company, however, Truck 18 will also be expected to be proficient in the response, use, and maintenance of the unit as well.
- 5. The intent of the Surf Rescue vehicles is a quick response onto the beach with qualified rescue swimmers. Equipment carried on Surf Rescue vehicles will be determined by the Surf Rescue committee, along with approval from the Surf Rescue Committee Chair, in consultation with the BOE. It is envisioned, that when in quarters, the Engine Company, or qualified swimmers, will don wetsuits and respond directly to the incident and onto the beach in the Surf Rescue vehicle. The Truck Company will respond in their apparatus and still function as a lookout/spotter using the aerial.
- 6. Unless directed otherwise, these specialized units are to remain in quarters for response or drill use.

- 1. The San Francisco Emergency Medical Services Agency (EMSA) has issued changes to current policy that will allow for an expanded Scope of Practice for EMTs.
- 2. Once trained, EMTs assigned to BLS Companies will be allowed to administer Narcan via intra-nasal route for altered mental status and/or suspected opioid overdose, and to administer High Dose Epinephrine in the form of an EpiPen autoinjector, via intermuscular route, for suspected anaphylaxis and/or severe asthma attack.
- 3. Training will be conducted on Target Solutions, and in Fire Stations, by EMS In-Service personnel. Education modules and a written examination should be completed on-line before hands-on testing is completed in the Fire Stations. H-3-Level 1 EMTs will be tested at Station 49. All EMTs, regardless of assignment, will receive training in the indications and application of these medications.
- 4. The Epi/Narcan kits will be kept in the Airway Bag on BLS Companies. The following Companies will receive the new medication kits:

BLS personnel from Engine and Truck Companies will be placed out of service, while monitoring their radios, in coordination with the Division of Training and their respective Division Chiefs. Station 49 personnel will be tested during the course of their ambulance shift.

1. The San Francisco Firefighters Union, Local 798, Units I & II, Memorandum of Understanding (MOU) Section 21: Holidays 20 Subsection 21.2 Fire Suppression Personnel states:

Twenty-four (24) hour fire suppression personnel and H-3 EMT/Paramedic/Firefighters shall be paid a holiday premium per pay period, excluding overtime compensation and premiums, as holiday compensation for the holidays specified in Section 21.1. Upon declaration by the Mayor of any holiday in addition to those specified in Section 21.1(b), twenty-four (24) hour suppression personnel and H-3 EMT/Paramedic/Firefighters shall be paid an additional holiday premium which will be calculated on a proportional basis by the Controller's office.

Employees who utilize sick pay on the shift commencing on the day before, the shift commencing on the day of, or the shift commencing on the day after a specified holiday shall not receive the holiday premium for two pay periods. For the Thanksgiving holidays, a single continuous usage of sick pay by an employee during any or all of the shifts commencing on the day before Thanksgiving Day, Thanksgiving Day, the Day After Thanksgiving, or the day after the Day After Thanksgiving, will result in that employee not receiving the holiday premium for the two subsequent pay periods. Employees on disability leave and/or employees working a forty (40) hour per week schedule on a temporary modified duty assignment on any specified holiday shall not receive holiday premium for that one pay period.

The holiday premium for employees who are members of the Retirement System under Charter Section A8.598 ("New Plan" or "Tier II") shall be paid a six and a half percent (6.50%) holiday premium July 1, 2017 through June 30, 2018.

Notwithstanding the above, employees who are members of the Retirement System under Charter sections A8.585 and A8.596 ("Old Plan" or "Tier I") shall be paid a seven percent (7%) holiday premium.

- 2. To receive Time Coming in place of the holiday premium, members must submit form 418.4 to the Payroll Office. (A sample of this form is attached to this General Order.) Time Coming forms will be effective from the time received. Only forms received in the Payroll Office between June 01, 2017 and June 30, 2017 will be accepted and processed. Forms received prior to the issuance of this General Order (i.e. May 26, 2017 or earlier) or after June 30, 2017 will NOT be accepted and processed, and will result in the member receiving holiday premium for Fiscal Year 2017-2018.
- 3. If a member experiences exigent circumstances during Fiscal Year 2017-2018 that may necessitate the change to/from holiday premium/Time Coming shall submit the request on the Department's General Form to the Deputy Chief of Administration, through the chain of command, for review and disposition. Such requests will be handled on a case-by-case basis.
- 4. The Suppression accrual rate for Time Coming taken in place of holiday premium is calculated as follows:
 - Tier I: multiply the number of hours worked per year, 2,532.40 by 0.07; then divide the sum by the number of pay periods, 26 to get 6.82 hours per pay period.
 - Tier II: multiply the number of hours worked per year, 2,532.40 by 0.065; then divide the sum by the number of pay periods, 26 to get 6.33 hours per pay period.

Hours available for member's TC accounts will be rounded off to two decimal places.

- 5. The H-3 Level I and II accrual rate for Time Coming taken in place of holiday premium is calculated as follows:
 - Multiply the number of hours worked per year, 2,080 by 0.065; then divide the sum by the number of pay periods, 26 to get 5.20 hours per pay period.

Hours available for member's TC accounts will be rounded off to two decimal places.

- 6. Directions for completing the form are as follows:
 - Indicate the total number of pay periods for the current Fiscal Year for which request the credit of the TC in place of Holiday Premium.
 - The TC hours will be accrued per pay period sequentially starting with the first pay period following receipt of this form by the Payroll Office.
- 7. H-3 Level I and Level II EMT/Paramedics Time Coming balances cannot exceed 240 hours. All other uniform personnel Time Coming balances cannot exceed 300 hours.
- 8. Attached are two copies of form 418.4. One copy is to be retained with this General Order and can be copied for submittal of Time Coming in lieu of Holiday Premium requests. Dear Ms. Sidd-Champion:

Deputy Chief Mark Gonzales forwarded me your letter dated May 9, 2017 discussing the San Francisco Firefighters Local 798's concerns regarding the H-23 Lieutenant classification. The City and Local 798 have met on numerous occasions regarding the H-23 classification. The parties have thoroughly discussed all of the issues raised in Local 798's May 9, 2017 letter, and the City believes that it has made clear its position on each of these issues. The City's hope is that this letter, coupled with the parties' prior discussions, will help Local 798 better understand the City's position regarding this matter.

Accretion of the H-23 Classification and the Applicable Terms and Conditions of Employment

The City disagrees with Local 798's assertion that, "it is essential that Section 2.1 of the MOU be amended to add the new [H-23] classification." Placement of new classifications into the bargaining unit and their coverage by the MOU is governed by Section 2.3 of the MOU, which states:

The City agrees that in the event it creates any new uniformed Fire Department classification below the rank of Battalion Chief during the term of this Agreement, such new classification shall <u>automatically be accreted to this bargaining unit</u> and be <u>covered under the terms and provisions of this Agreement</u>.

(Emphasis added.) Pursuant to Section 2.3, the H-23 classification was automatically accreted to the bargaining unit and covered by the MOU. Therefore, amending Section 2.1 of the MOU is not essential, and the parties can add the H-23 classification to Section 2.1 as part of cleaning up the provisions of the MOU in the next round of bargaining.

Hours for the H-23 Classification

Section 13.4 of the MOU states:

Uniformed Administrative personnel shall work a 40-hour work week. Daily work schedules to be set by the Bureau or Division Chief or Chief of Department.

As stated in the City's May 8, 2017 letter, the City will have the H-23 classification work 40-hour work weeks, which complies with Section 13.4. Pursuant to Section 13.4, the City is placing the H-23's on the following daily work schedule: 12-hour schedule on a 3-4 flop with 2 hours of planned overtime per week. Applying the 40-hour work week and setting daily schedules are within the authority granted to the City by Section 13.4 of the MOU.

Premium Pay

The City has consistently stated that it is not agreeable to providing "EMS Lieutenant Premium Pay or EMS Captain Premium Pay" to the H-23 and H-33, respectively. As has been previously explained to Local 798, the 2 hours of overtime per week results in an additional value worth approximately 7.5%, so the City is not willing to also provide a premium of 7.5% in addition to the overtime pay.

Meals and Rest Breaks

Notably, the parties have agreed on the appropriate meal and rest breaks. In fact, Chief Gonzales' May 8, 2017 letter and Local 798's proposal attached to its May 9, 2017 letter both state that break schedules shall include:

A total of one and one-half (1.5) hours for meal breaks plus three (3) fifteen (15) minute breaks during each 12-hour shift

As a result, there is no dispute about the substantive meal and rest break provisions to be applied to the H-23 classification.

Local 798's Concerns about Substitution of H-23s for H-33s

Similarly, the parties do not appear to have any disagreement about H-23s substituting for H-33s. In its December 28, 2016 letter, the Department clearly stated, "it is not the San Francisco Fire Department's intent to substitute H23's into positions currently held by the 33 permanently seated H33's." Local 798 agreed to the terms contained in the December 28, 2016 letter, with the caveat that they be memorialized in a side letter. Now, Local 798 has repudiated this caveat and stated that only an MOU amendment will suffice.

Local 798 may consider an MOU amendment addressing this matter to be desirable, but an MOU amendment is not necessary, per se. The City's is not agreeable to amending the MOU to address this issue.

Local 798's Claim That an MOU Amendment Is Necessary

The City's consistent position throughout the parties' discussions regarding the H-23 Lieutenant classification has been that an MOU amendment is not necessary, and the City understands that Local 798 has the opposite view. However, as discussed above, existing MOU provisions govern most of the issues raised by Local 798. While the parties reached agreement on some matters, the parties have been unable to reach agreement on others. Since the parties do not have an overall agreement, there is no agreement to be memorialized, either through an MOU amendment or any other means.

Furthermore, Local 798 has been inconsistent in the form of memorialization that It has demanded. While Local 798's May 9, 2017 letter demands an MOU amendment, Local 798 President Tom O'Connor has said on multiple occasions that he would be amenable to finalizing an agreement about the H-23 classification in a side letter. This position is also reflected in President O'Connor's letter of January 6, 2017 regarding the H-23 classification.

<u>Conclusion</u>

The City hopes that the information in this letter has helped Local 798 to better understand the City's positions regarding the issues related to the H-23 classification. If Local 798 believes that another meeting between the parties could be fruitful, the City is willing to meet again in the hopes that the parties might reach a mutually satisfactory resolution to this matter. If Local 798 would like to meet, please feel free to contact me at (415) 557-4857 to schedule a mutually agreeable date and time.

If Local 798 does not believe that an additional meeting could help the parties reach a mutually satisfactory resolution to this matter, the City intends to move forward with implementation of the H-23 classification, as described in the City's May 8, 2017 letter.

The parties have not bargained a full successor MOU in over ten (10) years, and many of Local 798's concerns regarding the H-23 classification appear to involve existing provisions of the MOU. The tenor of these discussions also indicates that the parties may have a number of significant issues to work through in the upcoming MOU negotiations. President O'Connor shared a similar perspective at the parties' meeting on April 6, 2017 when he stated that the discussions regarding the H-23 classification did not bode well for the MOU negotiations and predicted a frustrating experience.

The City believes that it would benefit both parties to commence bargaining for a successor MOU in the Fall to allow sufficient time to consider fully each other's proposals and endeavor to reach

agreement, especially since the parties will be subject to the timelines in Section A8.590-5(h), which were not in effect the last time the parties bargained. The MOU bargaining would be the appropriate forum to explore Local 798's concerns with existing provisions of the MOU, as well as clean up reference language, such as adding the H-23 classification to Section 2.1.

The City hopes that the parties can move forward in a respectful and productive manner regarding the H-23 classification and future labor relations matters.

This is the activity report for the Division of Fire Prevention and Investigation for the period from May 1 thru May 31, 2017.

1. BUREAU OF FIRE PREVENTION

a.) Revenue Generating Programs - The Bureau of Fire Prevention collects fees for services based on California state laws and regulations. For most of the services we provide, we are permitted to charge fees to recover costs. Table 1 outlines budgeted fees and revenues for the Division of Fire Prevention and Investigation and provides a percentage of where we are in relation to where we should be at this time.

^{*} Full recovery of revenues is expected for the categories of Annual High-Rise Inspection and Annual Permit Renewal Fees. Revenues for these programs fluctuate throughout the year based on the method of collection by the Tax Collector's Office.

Description of Revenue Programs:

1. Plan Review—The BFP's Plan Review Section is located within the Department of Building Inspection at 1660 Mission St. The Section reviews plans to verify compliance with State Building and Fire Codes.

2. High-Rise Annual Inspection Fees-All high-rise buildings in the State are required to be inspected annually, as mandated by the California State Fire Marshal. This program is designed to recover 100% of its cost, but revenues fluctuate throughout the year.

^{**} Revenue shown in this column does not reflect the overtime surcharge collected by the Tax Collector for Annual Permit Renewal Fees, which covers a portion of the overtime expenditures. The estimated amount of Annual Permit Renewal Fees that should be allocated to this category is \$204,160.

- 3. Construction Inspection Fees-The plans reviewed by the plan check division generate construction inspections which are carried out by the district fire inspectors.
- 4. Annual Permit Renewal Fees-Fire Department Permits are required by the California Fire Code for special uses, such as hazardous materials, public assemblies, etc. The fees for these permits are charged annually, and are collected by the Tax Collector's office after the initial filing fee is collected.
- 5. Overtime Fees-Many inspections and plan reviews are conducted on an overtime basis at the request of the applicant, who also pays for the service. Overtime for Place of Assembly Nighttime Inspection Surcharge is included in Annual Permit Renewal Fees.
- 6. Fire Dept. Permits-As stated above, certain uses require Fire Dept. Permits. This category is for the initial fees that are collected by the BFP when the permit is issued.
- 7. False Alarm Fees- The SF Fire Code requires that when the SFFD responds to excessive false alarm calls at buildings, the owners be charged a penalty fee. The BFP processes bills and payments, including the maintenance of records for such fees.
- 8. Referral Inspections-The BFP is responsible for inspecting occupancies requiring a fire department clearance as part of a federal, state, or local license.
- 9. Waterflow Request Fees- The BFP flows hydrants and performs analysis that provides fire protection contractors with the water supply information necessary to design fire protection systems. A fee is charged for this service.
- 10. Miscellaneous- This is a catch-all category for BFI subpoena revenue, photocopy revenues, and various consultation fees.
- 11. Pre-Application Fees-The plan review section meets with architects and engineers prior to the detailed design of buildings to discuss code issues specific to projects.
- 12. Re-Inspection Fees- During the course of the BFP's inspections, a Notice of Violation may be issued for fire hazards found. This fee is charged for each re-inspection until the condition is corrected.
- b.) Non-Revenue Generating Services Some of the services provided by the BFP are not fee generating in the same way our other programs are. These services are supposed to be paid for by local taxes, according to California law. Examples include: complaint inspections (fire hazard), public education presentations, telephone consultation, etc.
- **c.)** San Francisco International Airport SFFD BFP personnel provide fire prevention services to the airport, entirely under the SFO budget.
- **d.) Port of San Francisco** The Port Fire Marshal is the Fire Department's liaison to the Port and conducts construction and referral inspections, plan review, pier surveys, and issues permits along the Port's 7 ½ miles of waterfront jurisdiction. The Port Fire Marshal sits on the Joint Fire Operations Committee and is responsible for coordinating special events and activities of the Port with the Fire Department and other City Agencies.
- 2. Bureau of Fire Investigation The monthly and year-to-date report for the BFI is included as an attachment.
